2/ Laws 1999, Chapter 213 appropriates \$650,000 for operating expenses and \$350,000 for capital projects from the State Aviation Fund to the Grand Canyon Airport Authority in FY 2000. In FY 2001, an additional \$350,000 is appropriated for operating expenses and \$150,000 for capital project
3/ Laws 1999, Chapter 266 appropriates \$150,000 from the Arizona State Retirement System (ASRS) assets in FY 2000 for the administration of this
4/ Laws 1999, Chapter 277 appropriates \$1,250,000 in FY 2000 from the Emergency Medical Services Operating Fund to the Department of Health S. This appropriation is subject to the availability of monies in the fund.
5/ Laws 1999, Chapter 313 appropriates \$8,000,000 in FY 2000 from the Medical Services Stabilization Fund to Healthcare Group for reinsurance.
6/ Laws 1999, Chapter 313 appropriates \$8,000,000 in FY 2001 and each fiscal year thereafter from the Tobacco Settlement Fund to Healthcare Group reinsurance.
