- 16) School Facilities Board was created by L'98, Ch. 1, 3rd S.S., as amended by L'98, Ch. 164. It replaces the State Board for School Capital Facilities and continues to distribute monies encumbered by the School Capital Facilities Board.
- 17) Prior to FY 1999, the Department of Veterans' Services was called the Veterans' Services Commission.
- 18) Laws 2000, Chapter 98 changed the name of the Arizona Council for the Hearing Impaired to the Commission for the Deaf and the Hard of Hearing.
- 19) Laws 2002, Chapter 327 changed the name of the Board of Directors for Community Colleges to Arizona Community Colleges.
- 20) Laws 2002, Chapter 327 created the Division of Boxing Regulation within the Department of Racing to provide staff support to the Boxing Commission beginning in FY 2003.
- 21) Laws 2001, Chapter 22 created the Department of Housing. The act transferred all housing responsibilities to the Governor's Office of Housing on January 1, 2002. These responsibilities officially shift to the newly created housing agency on October 1, 2002.

- (32) Laws 2014, 2nd Special Session, Chapter 1 removed the Division of Children, Youth and Families from the Department of Economic Security (DES) and created a new stand-alone child welfare agency, the Department of Child Safety (DCS), starting in FY 2015. DES and DCS estimates have been adjusted back to FY 2013 for comparability.
- (33) Laws 2015, Chapter 19 (FY 2016 Agency Consolidation Budget Reconciliation Bill) merges the State Board of Appraisal into the Department of Financial Institutions effective July 3, 2015.
- (34) Laws 2015, Chapter 15 (FY 2016 General Appropriation Act) transferred the State Board of Education out of the Department of Education into its own separate unit.
- (35) Laws 2015, Chapter 208 transfers the administration of the Emergency Response Fund from the Department of Emergency and Military Affairs to the Department of Environmental Quality in FY 2016.
- (36) Laws 2015, Chapter 19 (FY 2016 Agency Consolidation Budget Reconciliation Bill) merges the Arizona Department of Racing to the Department of Gaming effective July 3, 2015.
- (37) Laws 2016, Chapter 128 (FY 2017 Agency Consolidation Budget Reconciliation Bill) merges the State Boards' Office with the Arizona Department of Administration Central Services Bureau.
- (38) Laws 2016, Chapter 128 (FY 2017 Agency Consolidation Budget Reconciliation Bill) transfers the Department of Fire, Building and Life Safety to the Arizona Department of Forestry and Fire Management, the Arizona Department of Housing, and the State Real Estate Department, effective July 1, 2016.
- (39) Laws 2015, Chapter 244 establishes the Weights and Measures Services Division within the Arizona Department of Agriculture (ADA) as of July 1, 2016. All authority, powers, duties and responsibilities previously granted to the Department of Weights and Measures are transferred to the new Division within the ADA, except for:
- Responsibilities relating to taxis, limousines and livery vehicles are transferred to the Arizona Department of Transportation.
 - Responsibilities relating to the Moving Truck Violation Enforcement Program are transferred to the Arizona Department of Public Safety.
- (40) Laws 2016, Chapter 145 renames the State Forester to the Arizona Department of Forestry and Fire Management and modifies the duties of the State Forester.
- (41) Laws 2017, Chapter 313 transfers the Radiation Regulatory Agency (ARRA) to the Department of Health Services (DHS), effective January 1, 2018.
- (42) Laws 2017, Chapter 199 amends A.R.S. §§ 15-1601 and 35-101 to eliminate the requirement that ASU-West and ASU-East be identified as separate budget units in the General Appropriation Act. This provision will take effect with the FY 2019 General Appropriation Act.
- (43) Laws 2019, Chapter 252 merges the Department of Financial Institutions (DFI) and Automobile Theft Authority (ATA) into the Department of Insurance (DOI) and renames the agency the Department of Insurance and Financial Institutions (DIFI), effective after June 30, 2020. Laws 2022, Chapter 50 transfers the Statewide Information Security and Privacy Office from the Arizona Department of Administration to the Arizona Department of Homeland Security.
- (46) The FY 2022 Higher Education Budget Reconciliation Bill (Laws 2021, Chapter 410) transferred the responsibilities of the Commission for Postsecondary Education to the Arizona Board of Regents effective January 1, 2022. The FY 2022 General Appropriation Act provided a full year's spending to the Commission. On the effective date, a portion of this funding became available to ABOR to continue administering the commission's programs.
- (47) The FY 2024 General Appropriation Act (Laws 2023, Chapter 133) provided a full year of FY 2024 funding to the State Board of Funeral Directors and Embalmers. Laws 2023, Chapter 194 subsequently transferred the funding and duties of the Board to the Department of Health Services retroactive to March 31, 2023. Chapter 194 was effective immediately upon signature on June 20, 2023.
