1/ Pursuant to A.R.S. 41-792.01, the Joint Legislative Budget Committee Staff reports the amounts appropriated to state agencies for rent of space in state-owned buildings. Agencies pay the greater of the appropriated amount or calculated rent based on actual occupancy of space. Collections are deposited to the Capital Outlay Stabilization Fund for appropriation for the operations and maintenance of the buildings. Rates for FY 2000 and FY 2001 are \$13.50 per square foot for office space and \$4.50 per square foot for storage space.

2/ Federal share calculated at State-Wide Cost Allocation Plan rent amount of \$10.22 per square foot of office space and \$1.91 per square foot of storage space.

3/ Represents funding for space occupied by the Attorney General - Department of Law for provision of legal services to the Department of Transportation.
